

PUBLIC NOTICE

The Texarkana Metropolitan Planning Organization (MPO) is offering a **public review and comment period** on Amendment Two to the Fiscal Year (FY) 2021-2024 Transportation Improvement Program (TIP) – Arkansas portion. The TIP is a 4-year listing of transportation projects and strategies, addressing the region’s transportation needs. The FY 2021-2024 Arkansas TIP identifies both local and state projects, that are supported by local governments and the Arkansas Department of Transportation (ARDOT) which will be included in the Statewide Transportation Improvement Program (STIP). The Statewide Transportation Improvement Program must be financially constrained. The purpose of the comment period is to gather public input on the proposed revision to the FY 2021-2024 Arkansas TIP for the Texarkana Metropolitan Planning Area.

Amendment Two is to add transit funding to fiscal year 2022.

Comment forms will be available on the MPO website, on the “Contact Us” tab. Comments from the public will be reviewed before the MPO Policy Board considers the document for adoption. The MPO is requesting that all comments be submitted by telephone, mail, email, or fax due to the COVID-19 and social distancing. If leaving a telephone comment, please speak clearly, leave your name, phone number with your comment. All comments will be accepted.
